determine the cause of temporary disability, criteria for recovery and restoration of working capacity

- Timely identify signs of disability,

- Comply with the rules of medical ethics and deontology; solve a set of tasks, related to the relationship between the doctor and the patient.

- To assess the patient's condition in order to make a decision on the need to provide him with medical care, to determine the possibility of treating the patient in a polyclinic
