Abstract of the working program of the discipline «Public health and healthcare, healthcare economics» the main professional educational program of higher education is the specialty program in the specialty 31.05.03 Dentistry, approved on 24.05.2023.

- 1. The purpose of mastering the discipline «Public health and healthcare, health economics» is to form the readiness and ability of students in the specialty 31.05.03 «Dentistry» to work in modern medical organizations of various profiles and their development of general cultural, general professional and professional competencies aimed at acquiring knowledge, skills and abilities in assessing the impact of social conditions and environmental factors on public health, mastering the basics of preventive and organizational and managerial activities, aimed at preserving and strengthening the health of each person, family and society as a whole, maintaining an active long-term life.
- 2. The place of the discipline in the structure of the main professional educational program of higher education: "Public health and healthcare, health economics" refers to the basic part of Block 1 "Disciplines (modules)" of the Federal State Educational Standard of Higher Education in the specialty 31.05.03 "Dentistry" (specialty level).

- ➤ Conduct selective medical and social research: collection, statistical processing and analysis of information on the health status of the population or its individual groups;

- > To conduct a critical analysis and reasoned interpretation of the results of their own and similar statistical observations;
- ➤ Calculate and evaluate the main health indicators of the population using socio-hygienic methods of collecting and medical statistical analysis of information on health indicators of the population;
- To assess the health status of the population and draw up an appropriate conclusion;
- ➤ Use information about the health of the population and the activities of medical organizations to propose measures to improve the quality and effectiveness of medical and preventive care to the population;
- ➤ To participate in the organization and provision of therapeutic and preventive, sanitary and anti-epidemic, preventive and rehabilitation assistance to various groups of the population, taking into account the socio-professional and age-sex structure of the population;
