How to distinguish a flu from the flu? It's not a problem. And maybe yes. Although these diseases and there are similar features and methods of treatment, they are caused by completely different organisms. An acute condition with a cold usually lasts longer, but with viral flu the state of health is worse. Below is a comparison of the general symptoms of the two diseases and the differences between them, made by professor of dermatology and toxicology at the Northern University in Ohio, Dr. Thomas Gossel.

Rest and relax. "Additional rest will give you the opportunity to direct all the energy of the body to recovery. It can also help avoid complications such as bronchitis or pneumonia, "advises Dr. Samuel Coron, a family doctor specializing in preventive medicine.

No parties! "When you are sick, parties or other entertainment can deplete you physically, jeopardize your immune system and prolong the runny nose," says Dr. Timothy Van Ert, a San Francisco and Saratoga, California doctor specializing in self-medication and preventive medicine . - No fun until you get better! "

Warm up. Dr. Sehnert advises to fight the cold in heat:

"It allows our immune system to concentrate on fighting infection, instead of spending energy on warming."

Take a walk. "Moderate exercise improves circulation, helping the immune system to distill the antibodies that fight infection," explains Dr. Sehnert. - Jump in the room on a small springboard for 15 minutes or walk on the street for 30 minutes, but refrain from complex exercises: they can tire you. "

#### **Practical part**

30-year-old woman, was taken to the clinic of the NSR with complaints of sweating, tremors and drowsiness, mood swings, tearfulness, general weakness, migraine pain throughout the body. The patient has type 1 diabetes mellitus (DM 1), identified 15 years ago, a severe course with constantly changing therapy due to recurrent hyper- and hypoglycemia. At admission, the blood glucose level was 1.2 mmol / l. According to the patient, during the week she noted a low level of glucose in the blood, although insulin at that time was not introduced.

The patient was diagnosed with diabetic macro- and microangiopathy (neuropathy, retinopathy). Concomitant diseases: Hashimoto's thyroiditis (in the phase of hypothyroidism) on replacement therapy with L-thyroxine; and osteoporosis, which is why she takes calcium and vitamin D. Family history: diabetes, ischemic heart disease, in the elder sister - a severe UPU with repeated surgical interventions (died at the age of 23 years).

The patient first received inpatient treatment and examination 5 years ago and during this period the reason for hospitalization has always been poor control of diabetes. 2 years ago, after severe transient hypoglycemia, all hormonal tests (without pathology) were made in the clinic, the insulin dose was reduced and the patient was transferred to insulin analogues. Despite the changes in therapy, diabetes mellitus remained poorly controlled - from severe hypoglycemia to hyperglycemia more than 30 mmol / 1.

When examined at admission: the general condition of moderate severity, the mood is suppressed. Reduction of subcutaneous fat, lipodystrophy zones under hyperpigmented skin. The body mass index is 16.7 kg / m2 (height 166 cm, weight 46 kg). Palpitation rhythmic with a heart rate of 110 beats / min, noises are not listened. Blood pressure 90/60 mm Hg. Pulse on peripheral arteries of weak filling. In the lungs, the breath is vesicular, there is no wheezing. CHDD 17 per minute. The abdomen is soft, painless. Diuresis is adequate.

During hospitalization, there were episodes of hypoglycemia with a blood glucose level of 1-2 mmol / L with loss of consciousness, which required almost continuous glucose infusion (insulin was not injected), during these attacks, the levels of C-peptide, insulin, glucose blood:
