

**Annotation to the working program of the discipline
"Russian as a Foreign language"**

of the main professional educational program of higher education - specialty program in the
specialty 31.05.01 General Medicine (educational program, partially implemented in English)

Form of study: full-time.

The term of development of the main professional educational program: 6 years.

Department: Foreign Languages.

1. The purpose of the discipline: to form the ability to implement the communicative intention in different areas of communication and types of speech activity; to understand by ear the content of the completed audio text; to transmit the content of the printed and audio text in oral and written forms.

2. The place of the discipline in the structure of the main professional educational program of higher education: the discipline refers to the disciplines of the variable part of the Block of the Federal State Educational Standards of Higher Education in the specialty "Medical care".

3. Requirements for the results of mastering the discipline: the teaching of this discipline is based on the following types of professional activity:

- therapeutic;
- expert-analytical.

The process of studying the discipline is aimed at the formation and development of the competencies Universal Competence-4 and General Professional Competence-10.

Indicators of competence achievement:

Achievement Indicator-1 Universal Competence-4: be able to use verbal and nonverbal means of communication and choose the most effective ones for academic and professional interaction.

Achievement Indicator-2 Universal Competence-4: observe the generally accepted norms of communication and expression of one's opinion (judgment), including in discussion, monologue, dialogue.

Achievement Indicator-3 Universal Competence-4: be able to communicate in a foreign language in the process of academic and professional interaction, use medical terminology, including in a foreign language.

Achievement Indicator-4 Universal Competence-4: be able to use modern information and communication tools and technologies.

Achievement Indicator-1 General Professional Competence-10: be able to use modern information and communication tools and technologies in professional activities.

Achievement Indicator-2 General Professional Competence-10: be able to comply with the rules of information security in professional activities.

As a result of studying the discipline, the student must

know: ways of expressing various semantic relations both in a simple and complex sentence, as well as in super-phrasal unity and in the text; language models at the level that allows working in an intercultural environment, developing documentation, basic rules of speech behavior in typical communication situations in the educational, professional, socio-cultural and official business spheres;

be able: to summarize informative material based on the read (listened) text, extract from the text (audio and written form) the main information and target information on the topic; be able to analyze public speech, conduct discussions, be ready for cooperation and conflict resolution in a team; reproduce the informative content of the text in written and oral form (monologue-reproduction, monologue-message based on text material);

possess: basic logical methods of information arrangement in oral and written texts, basic techniques of information search and analytical processing, basic logical methods of information arrangement in oral and written text.

4. The total labor intensity of the discipline: 18 credits (648 hours).

5. Semesters: 1-6.

6. Main sections of the discipline:

- 1) phonetic and conversational course;
- 2) grammatical and conversational course;
- 3) social and everyday sphere of communication;
- 4) educational and professional sphere of communication.
