#### **10.** Methodical instructions for students on the development of the discipline

Training consists of classroom classes, including a lecture course and seminars, as well as independent work.

In the process of study of the discipline used theoretical knowledge and practical skills to work with scientific and educational literature, as well as the analysis of historical and modern social and cultural situation.

Practical classes are held in the form of seminars, presentations and the use of visual AIDS, answers to control and test tasks.

In accordance with the requirements of the Evaluation Fund the educational process used active and interactive forms of training (lecture (visualization), discussion (group interviews with "brainstorming" and without it)). Independent work of students involves preparation for seminars, current and intermediate control and includes work with educational literature, making presentations, dictionary of cultural terms, writing an essay, preparation for test works and testing.

Work with educational literature is considered as a kind of educational work on the subject "History of medicine" and is performed within the hours allotted for its study (in the section of the IWS).

Each student is provided with access to the library collections of the Academy and the Department.

During the study of the discipline students independently conduct research work, make presentations and submit abstracts.

For each section of the discipline developed guidelines for students and guidelines for teachers.

Writing an essay contributes to the formation of research skills, skills to work with scientific literature, the correct design of their scientific work in the form of an abstract.

The student's work in the group creates a sense of collectivism and sociability.

Independent work contributes to the formation of an active life position, behavior, accuracy, discipline.

The initial level of knowledge of students is determined by the interview, the current control of mastering the subject is determined by an oral survey during classes, answers to control and test tasks.

At the end of the study of the discipline is carried out intermediate control of knowledge using test control, interviews on control issues.

#### 13. Conducting educational activities using e-learning and distance learning technologies.

In the conditions of introduction of restrictive measures (quarantine) associated with an unfavorable epidemiological situation, the threat of the spread of a new coronavirus infection, and other force majeure events that do not allow conducting training sessions personally, it is possible to study this discipline or part of it using e-learning and distance education technologies.

Teaching the discipline in the above situations will be carried out through the development of an electronic course with access to video lectures and interactive course materials: presentations, articles, additional materials, tests and various tasks.
