EXPLANATORY NOTE

Educational work at the university is an important condition for the formation of a student as a creative, comprehensively developed personality, a patriotic citizen who is able to make meaningful decisions taking into account social, ethical, cultural, and environmental aspects.

The work program of education of the main educational program of higher education-the specialty program on 05/31/03 Dentistry is a value-normative, methodological, methodological and technological basis for the organization of educational work.

- to show high social activity in all spheres of life, the desire to find new things and the ability to find non-standard solutions to life problems, to be competitive in socio-economic activities;
- to have a certain degree of orientation towards their interests and needs, to achieve success, to have rational thinking and a pragmatic attitude to life; to have the consciousness of a Russian citizen, civic qualities, patriotism, the desire to preserve the unity of Russia and to establish it as a great power, occupying one of the leading places in the world community (civil and political culture);

1. GENERAL PROVISIONS

1.1. Conceptual and value foundations and principles of the organization of the educational process in the Federal State Budgetary Educational Institution of the Ministry of Health of the Russian Federation

The educational process at the Federal State Budgetary Educational Institution of the Ministry of Health of the Russian Federation is organized on the basis of the work program of education, formed for the period 2023-2024, and is aimed at the development and education of students on the basis of basic universal values defined in the National Security Strategy of the Russian Federation.

The basic principles of the organization of educational work in SOGMA:

- consistency and integrity, taking into account the unity and interaction of the components of the educational system (substantive, procedural and organizational);
- conformity to nature, priority of the value of the health of participants in educational relations, socio-psychological support for the individual and ensuring a favorable socio-psychological climate in the team;
- cultural conformity of the educational environment, value-semantic content of the content of the educational system and organizational culture, humanization of the educational process;
- subject-subject interaction in the system "student -teacher", "teacher - academic group";
- the priority of initiative, independence, self-realization of students in educational and extracurricular activities, social partnership in the joint activities of participants in educational and educational processes;
- co-management as a combination of administrative management and student self-government, variability of educational activities;
- compliance of the goals of improving educational activities with the available and necessary resources; - awareness, completeness of information, information exchange, consideration of unity and interaction of direct and feedback.
- objectivism and humanism as the basis of interaction with the subjects of education.

1.2. Methodological approaches to the organization of educational activities in the Federal State Budgetary Educational Institution of the Ministry of Health of the Russian Federation

- The axiological (value-oriented) approach assumes that educational activities are based on strategic values: the value of human life and health.
- Spiritual and moral values; social values; the value of communication, contact and dialogue; the value of development and self-realization; the value of the experience of independence and the value of professional experience.
- The systematic approach considers the educational work of the Academy as a hierarchical system with its own functional structures, with connections between subjects.
- The system-activity approach is based on ensuring that the educational activities of students correspond to their age and individual characteristics and involves the upbringing and development of personality qualities that meet the requirements of modern society.
- The cultural approach involves the implementation of educational work based on the cultural traditions of society, the creation of a socio-cultural environment for students, the formation of a careful attitude to cultural achievements, the development of professional culture and work culture.
- The problem-functional approach allows for goal-setting, taking into account the identified educational problems and considering the management of the educational work system as a process.
- The research approach considers educational work as an activity with a research basis that introduces students to the methods of scientific cognition, forms a scientific worldview, develops thinking and cognitive independence.
- The project approach involves solving existing social and other problems through individual or joint project or research activities of students under the guidance of a teacher, which contributes to: the socialization of students in solving project tasks related to meeting the needs of society, the development of new forms of information search, processing and analysis; the development of analytical and critical thinking skills, communication skills and the ability to work in a team.
- The resource approach takes into account the resource opportunities for the development of the educational environment, evaluates the readiness to implement a system of

educational work through regulatory, personnel, financial, informational, scientific and methodological, educational and methodological, and logistical support.

- Health-saving approach is aimed at improving the culture of health, preserving the health of subjects of educational relations, which implies active subject-subject interaction of team members: to create a health-forming and health-saving educational environment, to change the internal position of the individual in relation to health to a consciously responsible one, to develop an individual style of health-creating activity of teachers, to develop and organize health-creating activities and a methodological arsenal of health-saving classes, on updating and implementing a healthy lifestyle.

- The information approach considers educational work as an information process consisting of specific operations: collecting and analyzing information about the state of a managed object; transforming information; transmitting information taking into account managerial decision-making. This approach is implemented by constantly updating objective and adequate information about the educational work system, which allows you to determine the current level of the educational system and have a clear idea of how to correct the situation.

1.3. Goals and objectives of educational work with students of the Federal State Budgetary Educational Institution of the Ministry of Health of the Russian Federation at the Faculty of Dentistry

2. THE CONTENT AND CONDITIONS FOR THE IMPLEMENTATION OF EDUCATIONAL WORK IN THE FEDERAL STATE BUDGETARY EDUCATIONAL INSTITUTION OF THE MINISTRY OF HEALTH OF THE RUSSIAN FEDERATION

2.1. The educational environment of the Federal State Budgetary Educational Institution of the Ministry of Health of the Russian Federation

The basic principles that express the requirements for the content, methods, and organization of the educational process in SOGMA:

- The principle of integrity, integration of the educational process (unity of the learning and upbringing process in the educational process). The educational environment of the university consists of the teaching staff, staff and students of the Academy. - The principle of an individual approach. Orientation towards the upbringing of a concrete student, not an abstract one, in the specific conditions of the educational process. In the process of pedagogical interaction, it is important to take into account the rules: reliance on the positive in the personality (creating a situation of success, treating the student's personality as self-worth, at the same time free, independent, creative and responsible); creating conditions of safety and emotional comfort; knowledge and consideration of age, individual and socio-psychological characteristics of students.
- The principle of subjectivity. The student, being a part of the educational environment of the university, is at the same time an active participant in the process of forming his personality and future professionalism, as well as an equal partner in the formation and implementation of the state youth policy.
- The principle of age conformity. The educational programs of junior and senior students should differ, taking into account not only the age characteristics of students, but also creating conditions for the formation of new personal qualities appropriate to their age.
- The principle of variability. It involves the use of various technologies in the content of the education process, forms and methods of organizing work with students.
- The principle of cooperation and co-management. The interaction between the teacher and the student is based on initiative, freedom of choice, independence, responsibility of the student and assistance, assistance, support of the teacher.

Educational and research activities

The system of professional education of specialists in the field of medicine and pharmacy is constantly being improved due to the widespread introduction of new information technologies, progressive forms of education using innovative methods, integration of educational and educational processes, scientific research, optimization of the system of multi-level continuing professional education of specialists. The improvement of the staffing of educational activities is aimed at improving the work on the selection and professional development of various categories of employees, curators of student academic groups engaged in educational activities.

2.5.3. Organizational and management support

The main task of organizational and managerial support of educational activities by the Dean's Office of the Faculty of Dentistry is the formation of an effective and purposeful management structure of educational activities. The activity should be based on such forms of organization as management, co-management and self-government.

Successful educational work depends on the interaction of all structural units of the university responsible for the organization of educational and extracurricular work.

Academic Council:

- defines the strategy and value bases of the content of educational work with students,
- approves the Concept of educational activities of the Academy aimed at the formation of a holistic educational space of the Academy;
- provides support for public, educational, creative, scientific and research initiatives, analyzes the practice of educational activities at the university,

- adopts resolutions aimed at improving educational work, youth policy and the development of self-government bodies of students at the university.

The Rector's Office examines the main directions, forms and methods of extracurricular work, educational activities, youth policy of the university, coordinates the work of university, faculty and cathedral structures on the problems of educational activities.

Curators of academic groups are appointed to organize educational work.

The main directions of the curator's work are:

- familiarization of students with the organization of the educational process, the Charter of the university, the Rules of residence in the dormitory, etc., the Rules of the internal labor regulations of the university, the rights and obligations of students;

- creation of an organized cohesive team in the group, carrying out work on the formation of the group's asset;

- work on the adaptation of students to the new learning system,

- creating an atmosphere of friendly relations between teachers and students;

- assistance to the student group's assets in organizational work, assistance in attracting students to research work and the development of various forms of student self-government; informing the head of the department, teachers of the department about educational affairs in the student group, about the requests, needs and moods of students.

The self-governing bodies of students are the most important element of the educational process, which ensures the participation of students in the management and organization of their own life at the university.

2.5.4. Financial security

The financing of educational work provides conditions for solving the tasks outlined in this Concept and in the documents of the state youth policy at the Federal and republican levels.

The implementation of financial support for the educational work of students is carried out through the following channels:

- at the expense of subsidies for financial support of the fulfillment of the state task allocated for the organization of events of cultural, physical culture and sports, recreational work with students

- at the expense of subsidies allocated for the implementation of programs for the development of student associations (on a competitive basis);

- at the expense of funds from income-generating activities and attracted funds from sources not prohibited by law.

The use of the listed funds for other purposes, including repair, household work and services, purchase of furniture and household equipment, unrelated to educational and social activities and other purposes, is not allowed.

2.5.5. Information support

Information support for the implementation of the Work program of education involves coverage on the official website of the Academy (SOGMA website <https://sogma.ru/>) information about the educational work being carried out and the activities of students' self-government bodies, the organization of sections on the VKontakte Telegram website covering socially significant and creative activities of students; the development of a network of information stands, exhibitions; holding information meetings, conferences, projects, events and educational campaigns, as well as the placement of relevant information in the newspaper Vesti SOGMA.

Information support of educational activities is aimed at:

- informing the subjects of educational relations about planned and past events and events of an educational orientation;

- filling the official website of the Institute with information about educational activities, extracurricular activities, youth policy), student life;

- informational and methodological support of educational activities; - placement of local documents of the Academy on the organization of educational activities; - monitoring of educational activities;

- organization of student media content;
- remote interaction of all participants (students, teaching staff, educational authorities, the public).

2.5.6. Scientific and methodological and educational support

The main activities of the Dean's Office of the Faculty of Dentistry of the Federal State Budgetary Educational Institution for the provision of scientific and methodological support of the educational process:

- participation of the dean's office in the orientation of teachers of departments and staff of the research laboratory to develop projects of practical importance for improving the education of students;

2.6. Socio-cultural space The socio-cultural space that encompasses a person and the environment in the process of their interaction ensures the increment of individual human culture.

The quality of the socio-cultural space determines the level of involvement of students of the Academy in active social relations.

In a single socio-cultural space, purposeful pedagogical influence on the social formation and development of youth is carried out directly with the help of the existing system of social institutions. The integration in the educational space of numerous subjects (cultural institutions, museums, theaters, cultural centers of the city of Vladikavkaz), united by solving common educational tasks, significantly increases their educational potential, creates conditions for its development. The interaction of social Academies is an effective way to assist the Academy in socializing students and orienting them to comprehend the basic values of national culture, which is the basis of a harmoniously developed personality. Through the use of the socio-cultural space of the city, opportunities for participation in various types of activities, connections and relationships of participants in interaction, which are based on the co-creation of young people, are expanded; additional opportunities are created to stimulate the active position of students. The education of youth requires the combined efforts of all state social structures to ensure the intellectual, moral, and cultural education of citizens devoted to the Motherland and ready to enrich its potential, multiply and protect its spiritual and moral values. The main idea of the "Strategy for the development of education in the Russian Federation for the period up to 2025" is to create a unified educational space based on the modernization of approaches, priority areas, modern pedagogical and psychological technologies. The strategy is aimed at strengthening social partnership, consolidating the efforts of society and the state, socially oriented business, science, art, faiths, mass media, universities, regions, local governments, non-governmental organizations in solving urgent problems of youth education.

3. MANAGEMENT OF THE EDUCATIONAL WORK SYSTEM AT THE FACULTY OF DENTISTRY OF THE FEDERAL STATE BUDGETARY EDUCATIONAL INSTITUTION OF THE MINISTRY OF HEALTH OF THE RUSSIAN FEDERATION
3.1. Educational system and management of the educational work system

The educational system of the Academy is an integral complex of educational goals and objectives, human resources that implement them in the process of purposeful activity, and relationships that arise between participants in the educational process.

The management of educational activities at the level of the Faculty of Dentistry, its coordination and organization are provided by the dean and deputy dean according to their functional duties and job descriptions, as well as by the Board of Curators.

At the university level, the organization and control of educational work is carried out:

- Rector and Vice-rector for educational work, supervising and coordinating the work:
- representative of the educational work management
- Board of Curators
- departments
- faculties
- The Council of training
- trade union committee of students
- the psychological and pedagogical service of these structures and their employees carry out their activities on the basis of the provisions approved in accordance with the procedure provided for in the Academy.

The main tool for managing educational work at the Faculty of Dentistry is the Work program of education and the Calendar plan of educational work for the academic year.

The management functions of the educational work system at the Faculty of Dentistry are:

- analysis of the results of educational work for the academic year at the faculty level
- planning of educational work on the organization of educational activities at the faculty for the academic year, including the Calendar plan of educational work;
- organization of educational work together with the Department of educational work, the Council of Curators, scientific and pedagogical staff of departments;
- control over the execution of management decisions on educational work.

Control over the effectiveness of educational work at the Academy, including through monitoring the quality of the organization of educational activities, conducted annually (comprehensive) or as necessary (for individual elements of educational work);

The dean's office of the faculty carries out the main educational work with students in terms of volume and content, interacts with the educational complex of the academy.

3.2. Self-management of students

The Council of Students of the Federal State Budgetary Educational Institution of the Ministry of Health of the Russian Federation is a social institution that carries out management activities, during which students of the Federal State Budgetary Educational Institution of the Ministry of Health of the Russian Federation take an active part in the preparation, adoption and implementation of decisions related to the life of an educational organization of higher education and their socially significant activities.

The purpose of student self-government is to create conditions for the manifestation of students' abilities and talents, self-realization of students through various types of activities (project, volunteer, educational, research and scientific research, student international cooperation, activities of student associations, leisure, creative and socio-cultural, participation in the organization and holding of significant events and events; participation in vocational guidance and entrepreneurial activities, etc.).

The tasks of self-government of students in the Federal State Budgetary Educational Institution of the Ministry of Health of the Russian Federation:

- representation and protection of the rights and legitimate interests of students, assistance in their implementation in cooperation with the administration and teaching staff of the Academy (including participation in special commissions of the SOGMA);

- participation in the assessment of the quality of the educational process and extracurricular activities;
- development of proposals and mechanisms for their implementation to improve the quality of the educational process and extracurricular activities of students, taking into account the actual needs of students in the educational, scientific, cultural, social, organizational and professional spheres;
- carrying out work aimed at increasing the consciousness of students and their demands on the level of their knowledge, promoting discipline in the territory of the SOGMA, fostering respect for the Academy's property;
- formation of civic culture, active citizenship of students;
- preservation and development of student traditions, traditions of mutual respect between students and employees of the Institute;
- assistance to the management bodies of SOGMA in solving educational, scientific, creative tasks, tasks of moral, cultural, personal, professional development of students, organization of their recreation and leisure, in holding cultural events (including those aimed at promoting a healthy lifestyle);
- informing students about the activities of the Academy;
- consolidation of the efforts of students (their associations) to solve social problems, implement socially significant initiatives of students, increase their involvement in the activities of students' self-government bodies;
- assistance in the development of interuniversity, interregional and international relations with student, youth and other public associations. The Council of Students of SOGMA functions in cooperation with the administration, management bodies, and other structural divisions of the Academy.

3.3. Monitoring the quality of the organization of educational work and the conditions for the implementation of the content of educational activities.

The main ways to assess the achievability of educational activity results at the level of the Dean's Office of the Faculty of Dentistry of the Federal State Budgetary Educational Institution of the Ministry of Health of the Russian Federation:

- methods of diagnostics of the value-semantic sphere of personality and methods of self-assessment;
- questionnaires, interviews, etc.;
- analysis of the results of various types of activities;
- student's portfolio;
- feedback from the head of practical training of the student, the employer, etc.

The key indicators of the effectiveness of the quality of educational work and the conditions for the implementation of the content of educational activities are:

- the quality of resource support for the implementation of educational activities (regulatory, personnel, financial, informational, scientific, methodological and educational, logistical, etc.);
- the quality of the SOGMA infrastructure (facilities for extracurricular activities of students, the realization of their creative potential; exhibitions; educational space, workspace and related labor and equipment; support services (transport, communications, etc.));
- the quality of the educational environment and the educational process in SOGMA (organization of creative active activity of students, use of socio-cultural space and social partnership);
- the quality of management of the educational work system at VSGIK (consideration of issues on the state of educational work by collegial bodies (Academic Council, Rector's Office, Council of Students of the Federal State Educational Institution of the Ministry of Health of the Russian Federation);
- organization of monitoring of educational activities at the Institute; stimulation of educational activities of curators and teachers;
- the quality of the student government of SOGMA;
- the quality of educational activities (substantive, procedural, organizational components, involvement and involvement of students of the Institute); - other indicators.
